Gorgan University of Agricultural Sciences and Natural Resources and Eötvös Loránd University, based on friendly cooperation and mutual enhancement, agree to cooperate in the following areas.

- I. Both parties agree to enhance: development of strategic partnership, international cooperation, and intensive research cooperation based on mutual respect and mutual benefits in the relevant areas and particularly Geography and Soil Science.
- II. Both parties have agreed to explore and develop the following exchange and cooperation programs:
  - a. Hosting and joining short-term visits and other exchange activities organized by either party;
  - b. Setting up a platform for academic exchange between the two faculties: On the basis of friendly communication, either university, sponsored by the other, sends faculty to give lectures and symposiums;
  - c. Cooperation in research involving Agricultural Sciences and Natural Resources, etc.;
  - d. Developing cooperation in the area of joint preparation of international projects.

transmission is confirmed by receipt of a successful transmission report and confirmed by mail.


This agreement is concluded for the period of 5 years, and will be automatically extended for another period of 5 years, unless one of the partners notifies the other of an intention to terminate the partnership. Written notification should be provided to the partner institution 6 months prior to termination. In order to ensure clarity of understanding, details of mutual finance and support of all joint projects will be agreed upon in writing by the designated parties prior to the initiation of any project.

Any changes or amendments to this Agreement are possible only on the basis of a written agreement of the Parties. Addendums to the Agreement shall be dated, numbered and signed by both Parties.

The Agreement is drawn up in 4 (four) identical copies, each copy having the value of the original. Each party will receive 2 (two) identical copies of the Agreement.


